



## Notice Pursuant to Art. 13 of EU Regulation 2016/679

Pursuant to Art. 13 of EU Regulation 2016/679 (hereinafter, the GDPR), and in relation to the personal data that T.I.S. srl will have at its disposal for the execution of the conferred assignment, we inform you of the following:

### Data controller and personal data protection officer

The data controller is T.I.S. Srl with registered office in Via Flaminia Km 33,900, Loc. Montelarco n.3, 00068 Rignano Flaminio (RM). ### Purpose of data processing

The purpose of the processing is the correct and complete execution of the assignment received. Your data will also be processed in order to:

- fulfil fiscal and accounting obligations;
- comply with the obligations imposed by current legislation;

Your personal data have been provided by you and may be processed by means of both paper and computer files (including portable devices) and processed in the manner strictly necessary to fulfil the purposes indicated above.

### Legal basis of the processing

T.I.S. Srl, as a professional company, processes your personal data lawfully, when the processing:

- is necessary for the performance of the contract to which you are a party or for the performance of pre-contractual measures adopted upon request;
- is necessary to fulfil a legal obligation incumbent on the professional;
- is based on your express consent, for the receipt of information on the company's activities.

### Consequences of non-disclosure of personal data

With regard to personal data relating to the performance of the contract to which you are a party or relating to the fulfilment of a legal obligation (e.g., obligations pertaining to the keeping of accounting and tax records), failure to provide personal data prevents the completion of the contractual relationship itself.

### Data storage

Your personal data, processed for the purposes indicated above, will be kept for the duration of the contract and, subsequently, for as long as the Controller is subject to storage obligations for tax or other purposes, as provided for by law or regulation.

### Communication of data

### Data Profiling and Dissemination

Your personal data are not subject to dissemination or to any fully automated decision-making process, including profiling.

### Transfer of data abroad

Your personal data may be transferred abroad for the performance of the contract signed with you, both to countries of the European Union and to non-EU countries, which may or may not be subject to an adequacy decision by the Commission.

- to request from the Data Controller and the DPO access to your personal data and information relating thereto; the rectification of inaccurate data or the completion of incomplete data; the erasure of personal data concerning you (upon the occurrence of one of the conditions indicated in Article 17(1) of the GDPR and in compliance with the exceptions provided for in paragraph 3 of the same article); the restriction of the processing of your personal data (upon the occurrence of one of the cases indicated in Article 18(1) of the GDPR);
- to request and obtain from the Controller - in cases where the legal basis of the processing is a contract or consent, and the processing is carried out by automated means - your personal data in a structured, machine-readable format, also for the purpose of communicating such data to another data controller (so-called right to data portability);
- object at any time to the processing of your personal data in the event of special situations concerning you;
- withdraw your consent at any time, limited to cases where the processing is based on your consent for one or more specific purposes and concerns common personal data (e.g., date and place of birth or place of residence), or special categories of data (e.g., data revealing your racial origin, political opinions, religious beliefs, state of health or sex life). Processing based on consent and carried out prior to the revocation of consent remains lawful;
